## Classification & Compensation

### Annual Increments:

As a continuation of last year, annual increment amount for fiscal year 09-10 will remain at one percent (1%).

## Payroll

### Payroll Training:

### Local Tax Increases:

Effective July 1, 2009:

-The City of Campbellsville/Taylor County will have a new 1% local tax on gross wages. This fee is in addition to the 1% already in place for Taylor County.

-The City of Elkton is raising their city tax from 1.5% to 2%.

(Listings of employees that will be affected by these changes have been mailed to the payroll officers in these agencies.)

### United Healthcare Vision/Spectera Reminder:

Just a reminder that we did terminate the contract authorizing payroll deduction for the voluntary optional insurance company United Healthcare Vision/Spectera (Utility #1249) effective June 30, 2009. Letters were mailed to all affected employees informing them of the situation and directing them to contact the company for continued coverage. Shortly after those were mailed we then emailed all of the payroll officers of the affected employees (providing each a list of those employees) asking that they again contact the employees and notify them of a new method in continuing coverage.
