Keeps time and attendance and other routine records. Performs the work of maintenance employees as required.

Work will involve some bending, standing, walking, lifting, and climbing.

# <u>TYPICAL WORKING CONDITIONS</u>: Incumbents in the job will typically perform their job duties under these conditions.

Will be on call 24 hours a day. Incumbents in this job title may be exposed to extreme temperatures which requires the following of safety procedures.

# **ADDITIONAL REQUIREMENTS:**
