Plans, assigns, and supervises the activities and employees in an agricultural marketing program pertaining to the grading, inspecting, packaging, and processing of agricultural commodities. Supervises the reporting of information on agricultural commodities. Conducts workshops on grading and reporting procedures. Contacts radio and television stations to assist in dissemination of news. Works with the U.S. Department of Agriculture to maintain a market news program and on grades and grade changes for the benefit of the livestock industry. Attends national workshops and meetings concerning agricultural marketing. Works with agriculture related associations to stay abreast of agricultural activities. Makes appraisals of livestock for insurance claims.

#### **UNIQUE PHYSICAL REQUIREMENTS:**

TYPICAL WORKING CONDITIONS: Incumbents in the job will typically perform their job duties under these conditions.

Work typically involves extensive contact with the public. Travel may be required.

#### ADDITIONAL REQUIREMENTS:

This status may be necessary for the length of time in this job classification. If this is necessary, it will be listed in the specific position description for the position at issue.
