Assists in setting up producer cooperatives to ensure adequate supply and quality of agricultural products. Researches, analyzes, and implements the efficient movement of agricultural products. Researches and develops new markets for ginseng. Establishes seasons for harvest and buying and establishes the harvest age. Develops good ginseng stewardship programs. Provides training and educational seminars for dealers, harvesters, stewards, and law enforcement.

#### UNIQUE PHYSICAL REQUIREMENTS:

#### TYPICAL WORKING CONDITIONS: Incumbents in the job will typically perform their job duties under these conditions.

Work typically involves extensive contact with the public. Travel may be required.
