WRIT OF ELECTION


Forty-Ninth District – House of Representatives

WHEREAS, due to the untimely death of Honorable Dan Johnson, Representative from the Forty-Ninth District of Kentucky House of Representatives on December 13, 2017, a vacancy exists in the Kentucky House of Representatives, Forty-Ninth District; and

WHEREAS, KRS 118.730 requires the Governor to issue a writ of election to fill a vacancy occurring in the House of Representatives when the General Assembly is not in session; and

NOW, THEREFORE, I, Matthew G. Bevin, Governor of the Commonwealth of Kentucky, pursuant to the authority vested in me by KRS 118.730, do hereby issue a writ of election to fill the vacancy in the Kentucky House of Representatives, Forty-Ninth District, to be held on Tuesday, February 20, 2018, and hereby direct that this writ be forwarded to the Sheriff of Bullitt County as required by KRS 118.730 and 118.740.
