EXECUTIVE ORDER 16-11

A petition for a local option election pursuant to KRS 242.020 was received on November 3, 2016 and filed at the Clinton County Clerk's Office and given to the Clinton County Judge Executives office on November 18, 2016. Upon request of the County Judge Executive, the County Court Clerk reviewed the petition for certification purposes. The County Judge Executive received a letter from the Clinton County Clerk verifying certification of the qualified voters equal to 25% of the votes cast in the last preceding general election. The petition presented and certified was as follows:

We the undersigned registered voters hereby petition for an election on the following question: "Are you in favor of the sale of alcohol beverages in Clinton County, Kentucky?"
