
EXECUTIVE ORDER 3-788

IN RE: Local Special Election – County of McCreary Pursuant to KRS 132.017(3)(b) and KRS 160.597(2)

BEING THAT a sufficient number of petitioners requesting a recall election for the "Nickel Tax" that was recently passed by the McCreary County Board of Education has been verified by the County Court Clerk's office, and that according to the above-cited regulations, the School board, upon confirmation of payment for the election and presentation of a question for the ballot,
