Receives formal training and performs closely monitored driver, vehicle and hazardous materials inspections for compliance with motor carrier laws and regulations under the Motor Carrier Safety Assistance Program. Issues citations when appropriate. Performs data processing of motor carrier observations and commercial motor vehicle inspections; and performs other duties as required.

### **MINIMUM REQUIREMENTS:**

#### **EDUCATION:**

High school graduate.

#### **Substitute EXPERIENCE for EDUCATION:**

One year of experience in the maintenance or repair of automotive or powered equipment will substitute for the required education.

#### **SPECIAL REQUIREMENTS (AGE, LICENSURE, REGULATION, ETC.):**

Must be 21 years of age. Must possess and maintain a valid driver's license to qualify for employment in this job classification. Must successfully pass an extensive background investigation prior to employment. Within 12 months of employment in this job classification must successfully pass part A and part B of the North American Standard Inspections test as required by the Federal

Motor Carrier Safety Administration. Must maintain any required licensure(s), certification(s), or other credentials for the length of employment in this job classification. Employing agency is responsible for ensuring employee possesses and maintains required licensure(s), certification(s) or other credentials.

**EXAMPLES OF DUTIES OR RESPONSIBILITIES OF THE JOB CLASSIFICATION:** *Examples of duties or responsibilities are not to be construed as describing what the duties or responsibilities of any position shall be and are not to be construed as limiting the appointing authority's ability to assign, or otherwise alter the duties and responsibilities of a position. This is not intended to be an exhaustive list.*

When assigned, attends and successfully completes North American Standard Driver/Vehicle Inspection courses and Hazardous Materials Inspection courses. Learns policies and procedures with respect to chain of command, standards of conduct, work conditions and expectations, the maintenance standards for uniforms and equipment and disaster scene security. Learns usage of communications equipment. Performs, subject to close supervision and monitoring, the following tasks: Inspection of driver/vehicle records for compliance with licensing permits and vehicle/driver operation laws and regulations. Physically inspects vehicles for safety defects. Checks cargo manifest to determine if hazardous materials are being carried, and if so, inspects for compliance with hazardous materials transportation laws and regulations. Places vehicles and/or drivers "out of service" for critical violations of the federal and state motor carrier safety regulations. Completes various forms and reports required by the Department of Kentucky State Police in accordance with operations manual. Maintains uniform and equipment in accordance with department policy. Communicates problems and inquiries through the chain-of-command and makes court appearances when required. Records vehicle information via data entry operations. Successfully completes in-service training as required by the department. Interacts with and assists the public.

**UNIQUE PHYSICAL REQUIREMENTS:**

Incumbents in this job title must possess the ability to walk, climb, stoop, and crawl around, on, and under vehicles to physically inspect them; must be able to lift and carry 50 pounds.

**TYPICAL WORKING CONDITIONS:** *Incumbents in the job will typically perform their job duties under these conditions.*

Incumbents in this job title typically perform their work at weigh facilities conducting commercial vehicle inspections.

**ADDITIONAL REQUIREMENTS:**

Upon employment, employees in this job classification may be required to drive a licensed vehicle. Applicants and employees in this job classification may be required to submit to a drug-screening test and background check. Applicants and employees in positions which perform job duties that may require contact with offenders in the custody or supervision of the Department of Corrections or with youth in the care, custody, or supervision of the Department of Juvenile Justice must meet qualifications pursuant to the federal Prison Rape Elimination Act, 28 C.F.R.115.17 and 115.317.
