Employing agency is responsible for ensuring employee has four years of experience as a licensed driver upon appointment into this job classification. Provides information and explains procedures to the general public. Reviews and determines eligibility of applicants for driver's license. Examines applicants by means of oral, written, performance and vision tests. Evaluates the ability of applicants with disabilities and recommends operator restrictions to compensate for disabilities to insure safe operation of vehicles. Examines motor vehicles for compliance with safety and legal requirements. Compiles reports. May assist with problem cases.

### **UNIQUE PHYSICAL REQUIREMENTS:**

Will need to be able to repeatedly get in and out of vehicles during the work day in the performance of testing duties.

TYPICAL WORKING CONDITIONS: Incumbents in the job will typically perform their job duties under these conditions.

Incumbents working in this job title perform work in an office setting.

#### ADDITIONAL REQUIREMENTS:

Upon employees in this job classification may be required to drive a licensed vehicle. Applicants and employees in this job classification may be required to submit to a drug-screening test and background check. Applicants and employees in positions which perform job duties that may require contact with offenders in the custody or supervision of the Department of Corrections or with youth in the care, custody, or supervision of the Department of Juvenile Justice must meet qualifications pursuant to the federal Prison Rape Elimination Act, 28 C.F.R.115.17 and 115.317.
