Classifies red cell enzymes and serum proteins by electrophoresis. Performs the various techniques used in the collection, preservation, receipt and examination of physical evidence. Prepares serological and chemical reagents and maintains quality control of same. Performs serological and/or genetic identification of biological specimens. Operates and maintains transmitted light microscopes, electrophoresis equipment, analytical balances, pH meters and other laboratory equipment. Prepares reports of examination results and statistical data relative to examinations and experiments performed. Reviews books, journals, periodicals and notes relative to the duties of the position. Prepares evidence for presentations in court proceedings and testifies in court as an "expert witness" regarding examination results. Presence may be required at crime scenes to assist with evidence gathering and processing.

UNIQUE PHYSICAL REQUIREMENTS:

The work requires standing for long periods of time and possibly assisting in lifting dead bodies.

TYPICAL WORKING CONDITIONS: Incumbents in the job will typically perform their job duties under these conditions.

Incumbents in this classification will typically perform their job duties in a forensic laboratory setting. May have some contact with contagious diseases and/or body fluids or regular exposure to noxious odors, chemicals substances and biohazardous compounds which may require the following of safety procedures. Regular handling of sharp surgical instruments

ADDITIONAL REQUIREMENTS:
